Privacy Policy



Private data we receive and collect

This Privacy Policy explains what happens to any personal data that you provide to us, or that we collect from you whilst you visit our site.

1. Information We Collect

3. Use of Your Information

We use the information that we collect from you to provide our services to you. In addition to this we may use the information for one or more of the following purposes:

- **3.1.**To provide information to you that you request from us relating to our products or services
- **3.2.**To provide information to you relating to other products that may be of interest to you. Such additional information will only be provided where you have consented to receive such information.
- 1 To inform you of any changes to our website, services or goods and products.
- **1** If you have previously purchased services from us, we may provide to you details of similar goods or services, or other goods and services, that you may be interested in.
- **1** Where your consent has been provided in advance, we may allow selected third parties to use your data to enable them to provide you with information regarding unrelated goods and services which we believe may interest you. Where such consent has been provided it can be withdrawn by you at any time.

4. Storing Your Personal Data

1 In operating our website it may become necessary to transfer data that we collect from you to locations outside the European Union for processing and storing. By providing your personal data to us, you agree to this transfer, storing or processing. We do our
